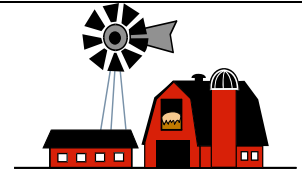

Letter from the Supervisor, Bill Udicious

Dear Residents:

At the Town Board meeting on November 10, 2004, the board voted unanimously to change the frequency of the Newsletter from monthly to bi-monthly effective January 1, 2005. The first issue for 2005 will be in February. The reasons for this change are:

(1) The Town Web Site has been used to disseminate information to the residents and this use can be expanded.

(2) Notices of Planning Board and Zoning Board meetings Agendas that have been published in the Newsletter are also published in 2 local newspapers, the Henrietta Post and the Sentinel. This information is also posted on the Town Bulletin Board.

(3) A yearly cost savings of approximately \$5,000.

We continue to look at the cost to operate the town and will welcome any suggestions that could result in cost reduction.

Town information, including past newsletters are kept on our website which is updated on a regular basis. Please visit it at www.rushconnections.com and click on the Town website button to the right. In this issue, I have included a tentative 2005 meeting date schedule for next six months for your convenience.

2005 OPERATING BUDGET

The Board approved the 2005 operating budget which called for a reduction in the town tax rate from \$4.14/\$1,000 of taxable assessed valuation to \$4.11/\$1,000 of taxable assessed valuation. Please refer to pages 7 and 8 for the operating budget detail for 2005 in table and pie chart form.

From the Director: A core service of any library is providing information to its users. Our library is often thought of as a repository for information or a disseminator of that information. TAXES

Bills for Town and County taxes due during the month of January will be mailed on December 30, 2004. If you do not have an escrow account and therefore pay your own taxes and do not receive a tax bill by the 14th of January, please call the town clerk's office for a duplicate bill. As in years past, the first installment must be made by the 10th of February in order to use the installment payment option.

Full payments must also be made by the 10th of February in order avoid any interest penalty. PLEASE NOTE THAT THE POST OFFICE CANCELLATION DATE ON THE ENVELOPE IS THE DATE I MUST USE TO DETERMINE IF A BILL IS TIMELY, NOT THE DATE ON THE CHECK.

A number of people are using bill paying services or other forms of electronic payment. These checks DO NOT HAVE A POST OFFICE CANCELLATION DATE and if received after February 10th will be considered late with interest due. Please give sufficient time for checks to reach my office to avoid any penalties.

TOWN BOARD MEETINGS

At this time the **Town Board** intends to hold the last official meeting for the year 2004 and the **Organizational Meeting** for the year 2005 on December 27th at 7:00 p.m. At this time the new Town Justice will be sworn in although his term does not begin until the 1st of January. All residents are welcome at this and all Town Board meetings.

Since the Newsletter will begin its bi-monthly publication in February 2005 it will not always be possible to print legal notices for matters coming before the Town Board. Remember that the two legal newspapers **THE HENRIETTA POST** and **THE SENTINEL** carry all legal notices for Town Board, Planning and Zoning Boards and those notices are always posted on the Town Clerk's bulletin board in the Town Hall.



Residents are invited to call the town offices at any time to inquire what matters are being brought before those three boards. Agendas are available at least three days prior to each meeting.

FIRE DISTRICT: The annual Fire District Commissioners **election will be held in December 14th, 2004 at the Rush Fire Station – 1971 Rush-Mendon Road from 6 p.m. to 9 p.m.** Mike Terzo is running for a five-year term as Commissioner. 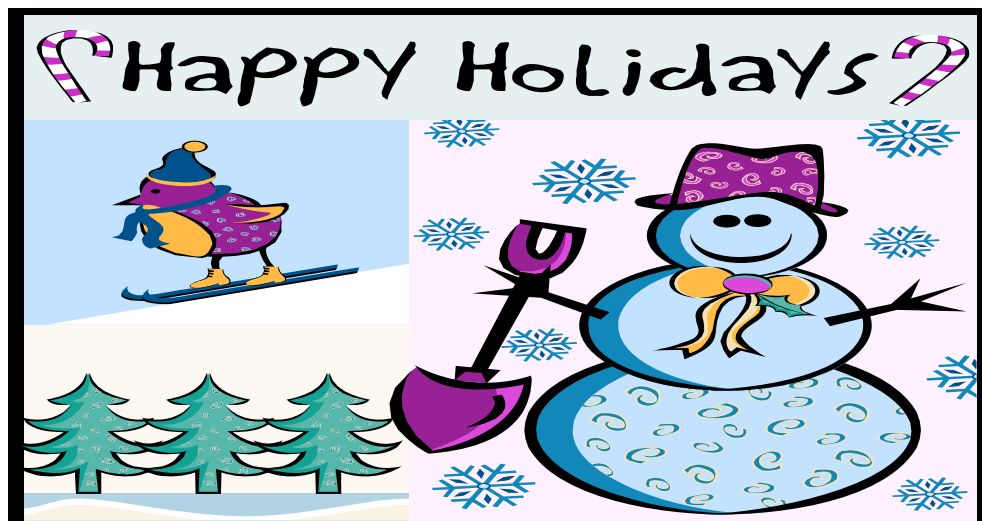
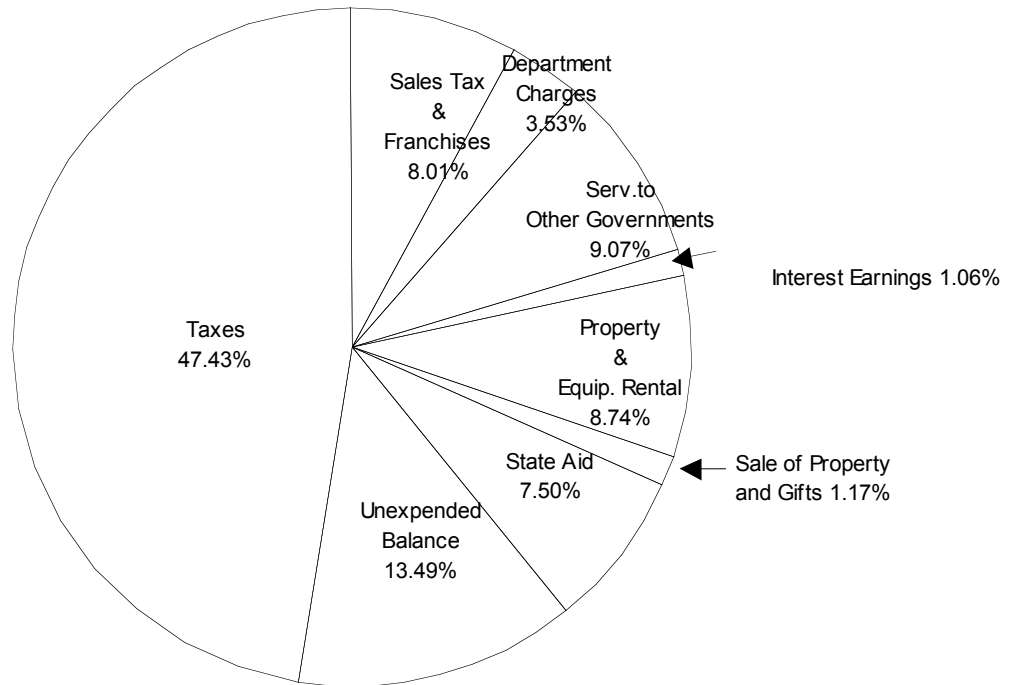
