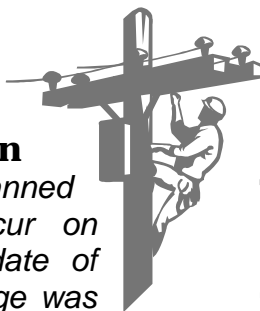

Dear Residents:

CANCELLATION of Electric Service Interruption

We had been advised of a planned power outage that was to occur on February 3rd with an alternate date of February 10th. This planned outage was for the purpose of working on high voltage equipment to install service to the new Barilla Plant in Avon. As of January 26, 2007, this scheduled outage HAS BEEN CANCELLED.



Replacement of the NYS Route 15 Bridge over the Lehigh Valley Trail

The contractor's schedule calls for Bridge and Highway work to start in late March 2007 and ending in early August 2007. Tentatively, the contractor intends to close the Lehigh Valley Linear Trail from late April through early June 2007.

Camera Surveillance

A camera surveillance system has been installed, tested and is in operation since January 19, 2007. Our Town Hall Library and parking lot are now protected with this system and will hopefully be a deterrent to anyone who may want to cause damage to our facilities or users of our facilities.

Emergency Preparedness Planning

In the event of a large-scale public health emergency affecting Monroe County, it may be necessary to administer vaccine and/or dispense medication to the entire population of approximately 735,000 citizens within as little as 48 hours. To make this a more manageable task, the County of Monroe has been divided into many Sectors, one of which includes Rush, Mendon and the Village of Honeoye Falls. Each Sector will form a Planning Team. These teams will form the core of the civil preparedness strategy. Each of these teams will develop a Point of Dispensing (POD) plan tailored to the unique needs of the populations residing within the respective sector while utilizing available sector resources. The Monroe County Department of Public Health will furnish a POD Plan template designed to assist each planning team and standardize efforts.

In February 2007, our Sector Planning Team will begin meetings to develop a plan. We will keep you informed on our progress.

Proposed Legislative Resolutions 2007

The Resolutions Committee of the New York State Association of Towns will meet in early February to review newly proposed resolutions and to evaluate existing resolutions. On February 21, 2007, the Resolutions Committee will present their final recommended resolutions to the delegates of the Association of Towns of the State of New York at the Association's Annual Business Session. We will have a delegate representing the Town at this meeting. A summary of the Proposed Legislative resolutions follow:

Resolution #1: Court Claims and Collateral Source Legislation RESOLVED, that the Association of Towns urges the Governor and the Legislature to reform the State's civil justice system and, in particular: (1) authorize towns and other local governments to defend themselves in the non-jury forum of the State Court of Claims where the State has been privileged to defend itself since the end of sovereign immunity more than 70 years ago; and (2) allow local governments to offset the cost of damage awards with collateral sources.

Resolution #2: Mandate Relief RESOLVED, that the Association of Towns calls upon the Governor and Legislature to repeal costly unfunded mandates on local governments by: 1) raising the project cost thresholds before WICKS would be applicable; 2) reforming prevailing wage; and 3) including the ability to pay, without

raising taxes, as a priority consideration for binding arbitration panels.

Resolution #3: Disability Benefits for Law Enforcement RESOLVED, that the Association of Towns supports legislation to amend General Municipal Law, §207-c to require that disability retirement benefits be extended to any law enforcement officer who has been receiving GML, §207-c benefit for a period of 36 months without the ability to return to work.

Resolution #4: Preserve Local Control over Active and Retiree Health Insurance Benefits RESOLVED, that the Association of Towns is opposed to any State mandated restriction which would affect a local government's control over the provision of health care benefits to its active or retired officers and employees.

Resolution #5: Reform Real Property Tax Exemptions RESOLVED, that the Association of Towns supports legislative initiatives that would NOT eliminate exemptions, but rather place the burden of qualifying for tax exemption on the organization claiming tax exempt status, and require such organizations to prove by clear and convincing evidence to local assessors that the property is used exclusively for exempt purposes.

Resolution #6: Reform Condominium Assessments RESOLVED, that the Association of Towns again calls upon the Legislature and the Governor to repeal Real Property Law §339-y so as to provide equal treatment for all types of residential housing and prevent the continuing abuses of §338-y.

Resolution #7: Special Franchise Assessment Litigation Charge-Backs RESOLVED, that the Association of Towns shall support legislation amending the Real Property Tax Law that would require the State to bear the costs associated with

the review of special franchise assessments by the Office of Real Property Services.

Resolution #8: School Funding Reform RESOLVED, that the Association of Towns calls upon our State leaders to eliminate costly unfunded mandates, which increase the cost of providing a public education and further strain the real property tax base.

Resolution #9: Efficient Highway Administration RESOLVED, that the Association of Towns calls upon the Governor and Legislature to enact appropriate enabling authority for local Road Classification as recommended by the NYS Local Road Classification Task Force which will permit local governments to objectively reduce to more appropriate levels, the costs of maintenance and repair of such low volume roads.

Resolution # 10: Speed Limits on Town Roads RESOLVED, that the Association of Towns urges the Legislature and Governor to extend to all towns the option – through adoption of local law – to assume responsibility and authority to set speed limits on town roads with their respective jurisdictions, and so long as those roads have been functionally classified by the Department of Transportation local laws.

Resolution #11: ATV use of Town Roads RESOLVED, that the Association of Towns supports an amendment to Vehicle and Traffic Law, §2405 that would allow municipalities, by local option, to designate their respective public highways, and/or portions thereof, as open for travel by ATV's in order to gain access to areas or trails adjacent to such highways, and that deletes the requirement that such use only be allowed when "it is otherwise impossible for ATVs to gain access to areas or trails adjacent to the highway."

Resolution #12: Pension Relief RESOLVED, that the Association of Towns calls upon the Governor, the New York State Legislature and the State Comptroller to establish a task force to evaluate the current pension program in order to make recommendations that will stabilize and lower employer (taxpayer) contributions for current members and lessen employer contributions for future members.

Resolution #14: Increase in Justice Court Funding RESOLVED, that the Association of Towns requests Legislative action to increase GML, reimbursement fees to assist local taxpayers in funding justice court operational expenses.

First of all, thank you to our patrons who were patient with us during the two days of installation, and also in the weeks afterward as the staff became accustomed to the changes in software. We now have an additional internet PC for patron use in the reference area, and *all* of the public PCs have had Microsoft Office programs and Windows XP installed. The installation went very smoothly thanks to the

automation staff from the Central Library. Their expertise is paid for with a portion of our Cost Share, a budgeted fee we pay annually to be a part of the Monroe County Library System (MCLS.) The Cost Share also pays for the computerized circulation system, computer security, database subscriptions, and part of the delivery fees for transporting books, other materials, and reserved items among all the Monroe County libraries.

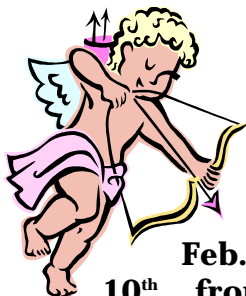

Hat by weekend sports anchor **Kevin Roche** of WHAM TV. No registration is required.

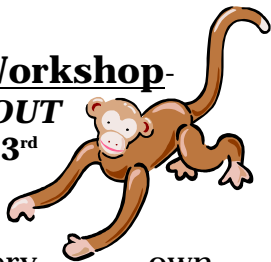
Stuff-n-Fluff Animal Workshop-

Rush Fire District Fire Department & Rush Ambulance

FIRE DISTRICT: The organizational meeting was held on January 2nd. Bob Faugh was elected as Chairman and Larry Meston was elected as Vice-chairman. Robert Kuhls was appointed as Treasurer and Pamela Bucci was appointed to the

Secretary position. The Fire Commissioners meeting will be held the third Tuesday of every month, 7 p.m. at station one. All of our meetings are open to the public.

FIRE DEPARTMENT AND AMBULANCE: The line officers for the department were approved by the Board of Directors at the January meeting. All are listed on the web site. The active and social officers are also listed.

ANNUAL REPORT: Total calls Fire & EMS for 2006 was 376 or one call every 23 hours. We had two serious fires in 2006, both by young people and improper use of candles. We averaged 16 people at the structure-type fires. We provided Mutual Aid for Fire-type calls, 15 times to our neighbors. It should be noted that we had 40 Automatic Alarms, malfunctions or Good intent alarms where we were not needed at all. The ambulance responded to 234 calls including 54 vehicle crashes. We used advance life support on 66 calls. We provided mutual aid EMS 13 times. We required mutual aid EMS 6 times. We transported a patient to the hospital 131 times. **Our average response time to get a properly equipped "first responder" EMT on scene was 4 minutes 90% of the time.** This response time is *exceptional* and beat almost everyone in Monroe County most of which are paid services. We have two "first responder" officers cars equipped with automatic defibrillators and several others with basic life support equipment.

3,600 hours were donated by you fellow Rush citizens who volunteer at the fire department/ambulance to respond to calls. These members also attended meetings, training and drills which came to over 3,500 hours of donated time. Another 600 hours was provided for the annual carnival. The officers and some members also attended local, county, regional and state meetings and seminars

to make your fire and ambulance service second to none!

FIRE PREVENTION: Keep up the good work; watch those candles and wood stoves. Keep the hydrant near your home clear of snow. Let's continue to have a safe winter!

RETENTION & RECRUITMENT: We gained 5 new members in 2006 and we lost five member for one reason or another. If you think you have some time and would like to help your fellow citizen, call Al Sweet at 533-1030. We have many jobs, we have scene support and station support memberships.

EXPLORERS: We have three new explorers (two boys and one young lady) and would like more. They are taught many life and property saving skills and work and train along with the active firefighters. This past month they all were certified in CPR and the use of an AED for Heart Attack victims. Wouldn't you feel safer if your son or daughter had the skills and training to possibly save YOUR life? They also have fun social activities. Any boy or girl between 14 and 21 may apply. Call Royer Pfersick at 533-9123 for more information.

The Rush Town Board will hold a public hearing on February 14, 2007 at 7:15 p.m. at the Rush Town Hall, 5977 East Henrietta Road to consider the adoption of the two following local laws. At this time the Board will heard all persons in support or opposed to these laws.

**LOCAL LAW 2007-1
SENIOR CITIZEN TAX EXEMPTION**

Sec. 1 Purpose

The purpose of this local law is to increase the income eligibility level of senior citizens exemption from real property taxes in the Town of Rush.

Sec. 2 Income Eligibility Level

(1) No exemption shall be granted if the income of the owner or the combined income of the owners of the property for the income tax year immediately proceeding the date of making applications for exemption exceed the sum of Twenty Five Thousand Nine Hundred Ninety Nine Dollars (\$25,999.00) except

that if the aforesaid income is more than Twenty Five Thousand Nine Hundred Ninety Nine Dollars (\$25,999.00), then such real property shall be exempt to the extend provided in the following schedule:

Sec. 3 Previous Legislation

This local law will supercede and amend the income guidelines established in Local Law 2004-1.

**LOCAL LAW 2007-2
TAX EXEMPTION FOR PERSONS LESS THAN 65 YEARS OF AGE WITH SOCIAL SECURITY CLASSIFIED DISABILITIES**

Sec. 1 Purpose

The purpose of this local law is to increase the income eligibility level of persons with Social Security classified disabilities, who less than 65 years o f age, for exemption from real property taxes in the Town of Rush.

Sec. 2 Income Eligibility Level

(1) No exemption shall be granted if the income of the owner or the combined income of the owners of the property for the income tax year immediately proceeding the date of making applications for exemption exceed the sum of Twenty Five Thousand Nine Hundred Ninety Nine Dollars (\$25,999.00) except that if the aforesaid income is more than Twenty Five Thousand Nine Hundred

Ninety Nine Dollars (\$25,999.00), then such real property shall be exempt to the extend provided in the following schedule:
