RUSH to participate in GREATER ROCHESTER AREA CLEAN-UP

The Town of Rush would like to invite town residents to participate in our third annual **"SPRING CLEAN-UP" on Saturday, April 21, 2007 at 9:00 AM.** This event is part of the Earth Day Greater Rochester Area Clean-up sponsored by Delta Laboratories, Inc., Rochester area Friendly's Restaurants, and Waste Management, Inc., and other local groups.

The Rush Spring Clean-up is being coordinated by Hans Schmittenner and Boy Scout Troop 334. Residents in the Town of Rush including families and youth groups, along with the Boy Scouts will be removing unsightly litter from our beautiful roads and parks. This will be followed by a get-together with pizza from Montesano's, snacks and drinks for lunch.

FIRE MARSHAL SERVICE

We have contracted with the Town of Henrietta to have them provide Fire Marshal Service for the year 2007. Both towns will monitor this closely during the year with the expectation that we will continue beyond 2007. We will realize a small savings but more importantly we expect quicker response time as they have a larger staff. This inter-municipal cooperation should result in a win-win for both towns.

HEALTH INSURANCE COST

In 2005, a thorough study of Health Care Plans was made by our Finance Director, Don

Reynolds, with the goal to reduce cost to the Town while still providing adequate Health Care to our full-time employees. As a result of this study, we made major changes to our Health Plan effective January 1, 2006, as follows: (1) Change to Blue Choice Value Plan. This plan had the same coverage as the previous plan but would require employees to pay a higher co-pay. (2) Require all employees and retirees to share in the plan cost (Town pays 90%, employees pay 10%) and also share in future increases in the same ratio. Previously, employees hired prior to January 1, 1997, were not required to contribute to the plan cost. **As a result of the changes made, the savings to the Town for 2006 was \$65,000.**

EMERGENCY PREPAREDNESS PLANNING

Monroe County hosted an exercise called PODEX (Point of Dispensing Exercise) on March 27 at the Dome Arena to simulate their response to a pandemic flu outbreak. As stated in my previous newsletters, the goal is to be able to administer vaccine and/or dispense medication to the entire county within a 48 hours period. We observed this exercise which will assist us as we continue to develop a plan for our Sector of the County (Rush, Mendon, Honeoye Falls). For more information, visit www.monroecounty.gov.

ADOPTED LEGISLATIVE RESOLUTIONS - Association of Towns

In my last newsletter, I had listed 14 resolutions that were proposed to the Resolutions Committee of the New York State Association of Towns. The Official Delegates to the 2007 Business Session **adopted** the following 16 Resolutions. They are related to issues that the Towns of New York State have determined to be most in need of legislative consideration. These were sent to: the Governor of the State of New York, The Members of the New York State Assembly and Senate, the Heads of the several State

Departments, Divisions and other agencies of New York State Government and Members of the United States Congress.

Resolution No.1: Increase in Justice Court Funding - Resolved, that the Association of Towns requests legislative action to increase GML, §99-1 reimbursement fees to assist local taxpayers in funding justice court operational expenses.

Resolution No. 2: School Funding Reform – Resolved, that the Association of Towns calls upon the Governor, the New York State Legislature, and other State officials to develop a solution that will provide adequate State funding for public education thereby lessening or eliminating dependence on local real property taxes without reducing funding to other local governments and local government programs; and BE IT FURTHER Resolved, that the Association of Towns calls upon our State leaders to eliminate costly unfunded mandates, which increase the cost of providing a public education, and which further strain the real property tax base.

Resolution No. 3: Mandate Relief - Resolved, that the Association of Towns calls upon the Governor and Legislature to repeal costly unfunded mandates on local governments, such as those identified above, or alternatively, to reform these mandates by: 1) raising the project cost thresholds before WICKS would be applicable; 2) reforming prevailing wages; and 3) including the ability to pay, without raising taxes, as a priority consideration for binding arbitration panels.

Resolution No. 4: Reform Real Property Tax Exemptions - Resolved, that the Association of Towns supports legislative initiatives that would NOT eliminate exemptions, but rather place the burden of qualifying for a tax exemption on the organization claiming tax exempt status, and require such organizations to prove by clear and convincing evidence to local assessors that the property is used exclusively for exempt purposes.

Resolution No. 5: Reform Condominium Assessments - Resolved, that the Association of Towns again calls upon the Legislature and the Governor to repeal real Property Law, §339-y so as to provide equal treatment for all types of residential housing and to prevent the continuing abuses of §339-y as described above.

Resolution No. 6: Special Franchise Assessment Litigation Charge-Backs - Resolved, that the Association of Towns shall support legislation (e.g. S.1373/A.6667 (2006) amending the Real Property Tax Law that would require the State to bear the costs associated with the review of special franchise assessments by the Office of Real Property Services.

Resolution No. 7: – Fair Assistance in Relief – Resolved, that the Association of Towns hereby requests the passage of legislation to provide for an amendment to the New York State Tax Law in order to provide a personal income tax credit equal in amount to the cost of real property taxes paid by a victim of a natural disaster whose property was rendered uninhabitable or commercially unusable as those terms are defined by law after the taxable status date.

Resolution No. 8: Efficient Highway Administration - Resolved, that the Association of Towns calls upon the Governor and Legislature to continue their support of the Consolidated Highway Improvement Program (CHIPS) and to explore every way possible to increase highway aid; and BE IT FURTHER

Resolved, that the Association of Towns calls upon the Governor and Legislature to enact appropriate enabling authority for Local Road Classification as recommended by the NYS Local Road Classification Task Force which will permit local governments to objectively reduce to more appropriate levels, the costs of maintenance and repair of such low volume roads.

Resolution No. 9: Preserve Local Cable Franchising Authority, Franchise Fees and Public Rights-of-Way Management. Resolved, that the Association of Towns calls upon the State and Federal Government to preserve local franchising authority, to preserve New York State Constitutional authority to manage locally owned public rights-of-way in the best interest of the public, and to preserve the taxpayer's authority to receive a fair and reasonable compensation (franchise fee) for the use of publicly owned rights-of-way.

Resolution No. 10: Pension Relief. Resolved, that the New York State Association of Towns calls upon the Governor, the New York State Legislature and the State Comptroller to establish a task force to evaluate the current

pension program in order to make recommendations that will stabilize and lower employer (taxpayer) contributions for current members and lessen employer contributions for future members.

Resolution No. 11: GML 207-c Disability Benefits for Law Enforcement. Resolved that the New York State Association of Towns supports legislation to amend General Municipal Law, §207-c to require that disability retirement benefits be extended to any law enforcement officer who has been receiving GML, §207-c benefit for a period of 36 months without the ability to return to work.

Resolution No. 12: Preserve Local Control over Active and Retiree Health Insurance Benefits. Resolved, that the Association of Towns is opposed to any State (e.g. A9722/S6397 (2006)) which would affect a local government's control over the provision of health care benefits to its active or retired officers and employees.

Resolution No. 13: Speed Limits on Town Roads. Resolved, that the Association of Towns urges the Legislature and Governor to extend to all towns the option - through adoption of a local law - to assume responsibility and authority to set speed limits on town roads within their respective jurisdictions, within the limits as defined in §1662-a of the Vehicle & Traffic Law, and so long as those roads have been functionally classified by the Department of Transportation as local roads.

Resolution No. 14: ATV Use of Town Roads. Resolved, that the Association of Towns supports an amendment to Vehicle and Traffic Law §2405 that would allow municipalities, by local option, to designate their respective public highways, and/or portions thereof, as open for travel by ATVs in order to gain access to areas or trails adjacent to such highways, and that deletes the requirements requirement that such use only be allowed when "*it is otherwise impossible for ATVs to gain access to areas or trails adjacent to the highway.*"

Resolution No. 15: Fund the Unfunded MS4 Mandate - Resolved, that the guarantee that the program is implemented and enforced uniformly throughout the State, the Association of Towns calls for fully funding the development, implementation and enforcement of this program.

Resolution No. 16: Publication of Legal Notices in Community Newspapers. Resolved that the Association of Towns calls upon the Governor and the Legislature to amend the General Construction Law to allow papers, which do not charge for the paper, but with an established and large circulation, to be considered newspapers in certain instances, to permit towns and other local governments to place the legal notices in the local publications which may reach a larger audience and/or be less expensive to publish.

RESIDENTIAL BRUSH PICKUP

The Town of Rush Highway Department will be conducting its annual brush pickup for our town residents commencing April 30, 2007 and running to May 4, 2007.

The roadside brush collection will be a one-week program and all brush should be out and **ready for collection by April 29th.**

We will begin on East River Road and will be working eastward.

Guidelines:

- 2 Truckloads (10 wheeler) per Household
- Residential pickup only
- All brush shall be no longer than 10 ft. in length
- All brush shall be placed 6 - 8 feet from edge of roadside
- Brush shall be placed parallel to the road
- Brush must be neatly piled
- *Do not place brush under any overhead wires, if possible.*
- *Do not place brush over any water or gas service shut-offs.*

Restrictions:

- No Stumps, Lumber, Trash, Leaves, or Manmade articles.
- Brush and limb wood only.
- Brush cut by residents only, NO CONTRACTORS

Stonybrook Road Transfer Station

Hours of operation at the Stonybrook Road Transfer Station will be on Saturdays from 9:00 a.m. - 5:00 p.m. and Sundays 12:00 p.m. - 4:00 p.m. Opening April 21st and closing on November 4th.

Town residences wishing to use a private contractor may pick-up a "Hauling/Usage Statement" at the Town Hall. While obtaining resident's permission, this form will identify the person or company hauling the material to the site, on your behalf. This form will be required at the site and is only good for that day.

If you have a special project planned and need to use the transfer station during the week, contact the Highway Dept. at 533-1770 at least one day in advance.

Lawn Damage

Due to this past winter, the highway department will be repairing all lawns damaged by our plowing operations. Residents who have used stakes or markers during the winter months at the edge of their properties should have them removed by April 16th.

When these stakes are used next season, please put them at least 3-4 feet off the edge of pavement so the plow operators will have room to clear the streets.

Now that we see the signs of spring approaching, and knowing we will be spending more time outside, I would like to remind residents of the following zoning laws. These three laws just happen to have the most frequent violations I've had to enforce.

Building Permits are required in the Town of Rush. Basically, any kind of structure you may want to build will require a permit. **Sheds, additions, fences, towers, swimming pools, etc., all require a permit to erect.** If you are unsure, the best thing to do is to call to confirm the need for a permit for your project before you start. Permit applications are available daily at the town clerk's counter. Completed applications are processed by the Code Enforcement Officer. **Be aware that it has become common practice for attorneys, banks, insurance companies, etc. to ask for building records before a property can transfer to a new owner.** If an official permit record of your project is not on file, the closing could be postponed. Or worse yet, the addition may have to be removed.

Storing Unlicensed Vehicles in the open is a violation. You should be aware also that it is unlawful to store unlicensed vehicles outside on your property. You can store as many as you would like in a building, but **none outside.**

Open Burning is a Violation. Open burning is a practice that many residents become involved with at spring cleanup time. **However, open burning is unlawful and could result in a hefty fine being levied against a repeat violator.** All residents should be aware that any open burns (camp fires, trash fires, bon fires, etc.) are prohibited. **Some conditions may allow an open burn permit to be issued,** but not many. If you intend to ask for a permit to burn, please call

at least one day in advance. **Please do not wait until after you've struck the match.** A violation of any of the above may require your attendance in court. I hope that will not be necessary for any resident.

In the next newsletter I will address more of the most common violations in the category of property maintenance.

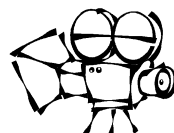

In early April, the Assessment Office will be mailing out a "Change of Assessment Notice" to all parcel owners in Rush. Approximately 95% of these notices will show no change of assessment for the 2007 roll year. The remaining 5% will be parcels that have been split or merged, new home constructions or other smaller projects with appropriate assessment changes.

These Notices are a requirement of New York State's Annual Reassessment Program and are called "Impact" Notices. They will show an estimated change in the town portion of a property's tax burden between 2006 and 2007. Again, the vast majority of these notices will show no change in assessed value and little or no change in the estimated town tax for 2006 and 2007. If you have any questions pertaining to the notice, feel free to call our office at 533-2330.

The fire commissioners and Fire Chief met with a representative of the Henrietta Fire Marshal's office at our last meeting. The town has contracted them to take care of the fire code and other related activities. They want to work with the residents of Rush and will answer any questions you may have. Contact them via the Town Hall at 533-1312. There are new codes in effect for all of NYS and before you get into trouble give them a call.

FIRE DEPARTMENT & AMBULANCE:

FUND DRIVE: In 2006 your volunteers responded to an emergency call every 23 hours. They donated over 7,000 hours to provide service, attend meetings, attended training and drills, raise funds and maintain buildings and equipment with only ONE goal and that is to provide the best service we can for you and your family. We are 100% volunteer, NO ONE GETS PAID! We have one of the last free ambulance services in the county and cover 99.5% of our calls!

You should receive the annual fund drive letter for the AMBULANCE and FIRE DEPARTMENT operation in the first week in April. We would appreciate your quick response to this annual appeal. We will not be going door to door this year. If you give via United Way and chose the Rush FD please let us know. *If you do not select us, we do not receive any United Way donations! 90% of the Ambulance operation and 100% of the cost of new ambulances (7 since 1939) came from fund drive money.*

Other vehicles such the three Rescue trucks, two brush/utility trucks, ATV, Boat and trailer were purchased with fund drive money, memorial donations and carnival profit. Other items such as several AEDs, "Jaws of Life", water rescue, portable radios, pagers, thermal imaging camera, airbag system and other expensive items were bought with money from these funds.

We also use fund drive money for our complete scouting, fire prevention programs, training and seminars. No fund drive money is used for our few social events. Very few Fire Depts. or Ambulance services can say that! We

are very proud and thankful to the Rush residents who support us with donations. **WE THANK YOU IN ADVANCE FOR YOUR CONSIDERATION!**
