V. REPORTS OF OFFICERS AND COMMITTEES

Councilman Anderson had no report.

Councilwoman Sluberski stated that dates for Councilman Riepe and herself to perform a court audit have been submitted to Court Clerk Sally Newell and a date will be determined.

Highway Superintendent David reported that the Highway Superintendents met with 55th District Senator James Alesi and representatives regarding C.H.I.P. monies. Mr. David reported that the Highway would be receiving \$1.00 less in total than last year. Highway Superintendents will be meeting with Assemblyman Harry Bronson of the 131st District next week.

Town Clerk Bucci received one application for the Town Board position. The Clerk's Office has collected over \$2M in 2011 Town & County Taxes to date.

Supervisor Udicious stated that the energy audit meeting previously scheduled with Chris Burrell had been cancelled due to his illness. The meeting will be rescheduled for February 23rd, 6 PM, at the Town Hall.

VI. OLD BUSINESS

A. Farmland Protection Meeting – A Farmland Protection meeting date has been scheduled and posted for Tuesday, February 15, 2011, at 7:30 PM in lieu of the Planning Board meeting.

VII. NEW BUSINESS

A. Monroe County Public Safety Communication Project – The Communication Tower provides a communication mechanism to emergency responders. A letter from Monroe County dated January 28, 2011 identifies Rush as an interested agency. Site improvements include two additional antennas, new generator and a new DC power plant. Supervisor Udicious will contact Monroe County Director of Public Safety Steve Bowman for further information.

B. Request for Tax Exemption – Volunteer Firemen – Town Clerk Bucci forwarded a request from Rush Fire Commissioner Robert Faugh regarding tax exemptions. Attorney Pavia researched the request and found that a statutory provision does exist, however, the counties allowed the exemption have to meet a certain census population. Monroe County's population does not qualify with the census requirement of the State Law and Rush cannot adopt the exemption provision. Supervisor Udicious stated that a response will be sent to Commissioner Faugh.

C. CDBG (Community Development Block Grant) Request for 2011 – Supervisor Udicious will be submitting two requests for ADA compliant facilities which include an ADA compliant high school standard basketball court (proposed site location included). Highway Superintendent David has been instrumental in providing cost and work estimates. A fence will also be included in the request. Additionally, included in the request is a hearing loop for the Meeting Room. Loop information has been provided by Applied Audio, recommended by Resident Dave Sluberski. The Town will not be contacted about the outcome of the CDBG grant award until August 2011. If approved, the town's Highway Department will provide the bulk of the work involved in the basketball court project.

VIII. OPEN FORUM

Supervisor Udicious opened the floor to anyone wishing to address the board.

Supervisor Udicious requested the Board remain for an attorney-client privilege discussion.

IX. ADJOURNMENT

There being no further business, a motion was made by Supervisor Udicious that the meeting be adjourned at 7:20 PM was approved by common consent of all councilpersons present.
