## RESULTS OF THE 2013 ELECTION

**Congratulations** to Cathleen M. Frank, who was elected for 4 year term as a Town Board member following her one year appointment.

Welcome and **Congratulations** also to Rita McCarthy, who was elected to a 4 year term as Town Board member. Rita will be replacing Bill Riepe, who has served the Town since 2010 (as well as a term from 2002-2005), and will be retiring at the end of 2013. Thank you, Bill. You will be missed.

I was also re-elected and am greatly looking forward to serving the Town as Supervisor for the next 2 years.

## OPERATING BUDGET

The 2014 Operating Budget was approved at the October 23<sup>rd</sup> Town Board meeting.

The Budget calls for a 2014 tax rate per \$1,000 of Taxable Assessed Valuation of \$4.54- unchanged from 2013. See the tax rate graph which follows.

The 2014 Taxable Assessed Valuation at \$284,971,022 is virtually unchanged from 2013 and has increased less than 2.4% in the last 4 years combined. The total levy of \$1,326,250 is well below the 1.66% limitation set by the NY Property Tax Cap legislation.

Below are some of the individual highlights from the Budget:

The cost of health insurance premiums is expected to increase 10% for 2014 making family coverage almost \$17,400. The Plan will change to a comparable Affordable Care Act compliant plan (Platinum) while the employee contribution will remain at 10% for 2014. The Budget for healthcare totals \$218,525 – an increase of \$17,308 over 2013.

The Town contribution for NYS Retirement for 2014 will decrease slightly from 21.0% of covered payroll to 20.3%. The State Comptroller projects that the rate will continue to decline in coming years. Participation in this system is required by NYS law. The Budget for NYS Retirement totals \$173,100- a slight increase over 2013 due to increased covered payroll.

Town employees will receive a 2% wage increase for 2014. Wages of the Town Board and Supervisor will remain unchanged for the 2<sup>nd</sup> year. Sales Tax distributions from Monroe County have been strong and have more than recovered from the decline in 2009. We expect to receive \$300,000 for 2014.

Highway Capital outlays include \$205,000 for a Tandem Axle Truck of which \$120,000 will come from a Highway Capital Reserve for that purpose. No significant General Fund Capital outlays are planned for 2014.

Highway improvements include \$62,000 for prep work on Stoneybrook, Phelps, and smaller projects. Highway maintenance includes \$57,000 for repairs and maintenance for Biondo Court, Delia Trail and Lyons Road.

The Supervisor Contingency is increased to \$48,000 as the age of our “new” Town Hall building suggests increased risk for larger repair expenditures.

The Town will utilize \$128,400 of our unexpended fund balances to fund a portion of the 2014 Budget. This can be thought of as similar to using some of your savings to pay bills. Even so the Town is projected to have an unexpended balance at the end of 2014 equal to about 33% of annual expenditures.

This is considered a sound fund balance position. See the fund balance graph which follows.

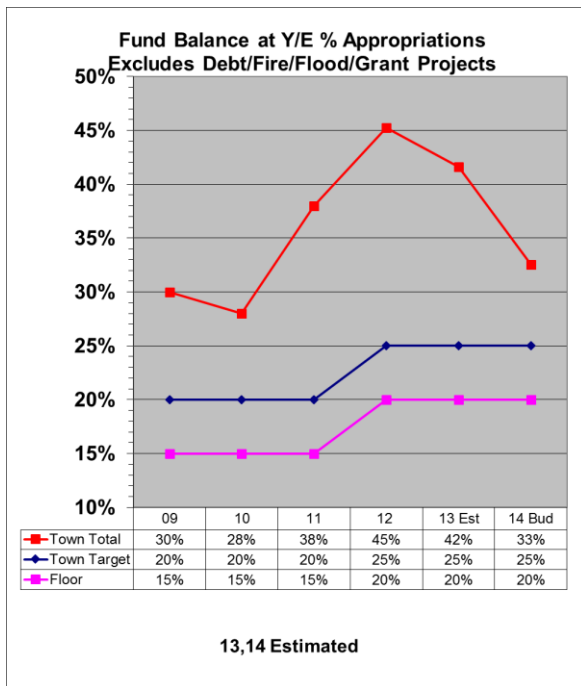

### 2013 TOWN & COUNTY TAXES By Order of the Rush Town Board Pamela J. Bucci, Town Clerk

Town and County tax bills will be mailed the 1<sup>st</sup> week of January. If you have not received a tax bill by January 15<sup>th</sup>, and do not have an escrow account, please call the town clerk's office for a duplicate bill. All bills can be found on the Monroe County website at [www.monroecounty.gov](http://www.monroecounty.gov). Go to "view taxes online".

Taxpayers have three payment options in order to satisfy their property tax obligations. Tax Payments are payable to Pamela J. Bucci, Collector, Rush Town Hall, 5977 East Henrietta Road, Rush, New York 14543 through May 31<sup>st</sup> or the Monroe County Treasurer beginning June 1<sup>st</sup> in the following manner:

Jan 1-Feb 10...No interest due  
Feb. 11-28...1.5%  
Mar. 1-31 ...3%  
April 1-30....4.5%  
May 1-10 ...6%  
May 11-31...6% interest, plus notice fee

**Full Payments** – due without interest by February 10<sup>th</sup> 2014.

**Installment Payments** - Total bill must exceed \$100 to use this option. The 1<sup>st</sup> installment **must be paid by February 10<sup>th</sup>**. If the 1<sup>st</sup> installment is **not** paid by February 10<sup>th</sup>, the total bill plus interest is due.

**Partial Payments** - An **initial payment** of at least 25% of the taxes due plus any accrued interest can be made at any time between January 1<sup>st</sup> and August 20<sup>th</sup>. Any payment paid on or before February 10<sup>th</sup> is interest-free. An interest charge will be calculated payment is made after February 10<sup>th</sup>.

**Payments by Credit Card** – A fee for this service will be charged. You may pay either at the Town

Hall or on-line at [www.monroecounty.gov](http://www.monroecounty.gov). Select "view taxes on line".

**Online Bank Payments** – Because banks cannot guarantee your payment will be delivered by the due date, **utilizing this method is at your own risk.**

Payments made after May 31<sup>st</sup> are payable to Monroe County Treasurer and can be mailed to: PO Box 14420, Rochester, New York 14614, or in person at the Monroe County Treasurer's Office, at 39 West Main Street, Room B-2, Rochester, New York 14614. ## HAPPY BIRTHDAY PARTY MARCH 3<sup>rd</sup> 2014

Real Property Tax Law lets us celebrate your Birthday on the first of the year (one of the owners must be 65 years of age or older as of December 31 of the assessment roll year.) So if a member of the house hold turns 65 this year, Happy Birthday! And as a special gift the State will allow you to apply for the Senior STAR Exemption! But you must apply before March 1<sup>st</sup>! **Please note the registration deadline for Basic Star is December 1<sup>st</sup>.**

This exemption if you qualify (there is an income limit) would save you roughly **\$550** in School Tax... In recognition of your Birthday the Assessor's office will have cake and cookies available all day on March 3<sup>rd</sup> 2014, because March 1<sup>st</sup> is a Saturday.

### BELL COLLECTION ON DISPLAY AT TOWN HALL

Ray Bock, owner of Bock's store, in the 1930's began collecting bells and displaying them in the store. Ray, who lived in the village of Rush all of his life, was a member of the American Bell Association. His collection began with a bell from a school in North Rush.

Ray's son Bob later became owner of the store and care keeper of the bells, which eventually numbered in the two thousands. They were displayed throughout the store, until Bob retired and closed the store in 1998.

There are bells that chimed under the step of a stagecoach, bells from Indian tribes that were used to summons their gods, an 1878 Swiss cow bell, and a three hundred year old bell from a Cathedral in Rome. According to Bob no two sound alike.

Bob has graciously loaned a few of the bells to be displayed, in the glass case in the Town Hall. Many of you will be seeing them for the first and for some they will be remembered from "the good ole days".

If you have any type of collection you would like to share with the community, contact the Historian's office and we would be glad to display them for a month or two and then return them to you.

### A FOND FAREWELL

After careful and thoughtful consideration, I have decided to "retire" from my position as Town Historian, at the end of December. I have rewritten this part of my newsletter about a dozen times. I guess the reason is because I AM finding it difficult to say good bye.

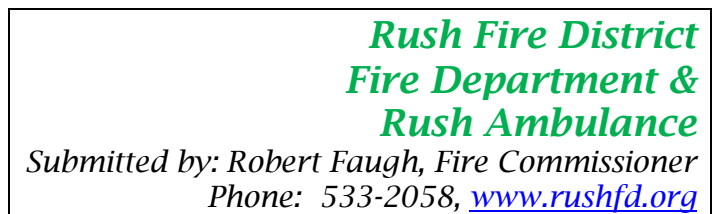
## TRAVEL & EVENTS

They also stated they were happy with the job our treasurer Robert Kuhls has been doing and that all accounts were correct. The final report will be available on the Dept. of State web site within two months along with our reply.

The new pumper delivery has been delayed. They hit a deer on the way from Michigan to Pennsylvania. So it had to go back to Spartan Motors to be repaired.

The fire district held the annual inspection dinner at the Riverton Country Club. Every active member received a three season jacket. Mike Terzo Sr. was chairman for the event.
